Subject: LICENSE APPLICATINS / RENEWALS 2018 SEASON

The boxing family

Today marks exactly twenty one days before the end of May 2018 and almost six weeks into the new financial year which commenced on 1 April 2018.

The exciting news is that almost one thousand out of one thousand two hundred and eight (1208) licenses of our 2017 licensees have already renewed their 2018 licenses. We thank you for profusely and urge you to keep up the good practice!

As it is now common knowledge the deadline for license renewal for the new season of 2018 ended on 31 March 2018. Subsequent to that the Board of BSA extended window period for renewals and /or new applications by further fifty three days until the **23 May 2018**

It is very important to remember that the approval of license application is strictly the competence of the Board and not even the CEO or Management can approve to issue or terminate any license. All late applications that were received since 1 April 2018 will therefore be considered for approval by the next Board Meeting which is scheduled to take place on **Saturday 26 May 2018** to consider all late applications.

Our clarion call to anyone who still has not renewed current license or lodged new application is that they should do so on or before **16:00 Wednesday 23 May 2018**. **Please note that the deadline is 23 May 2018 and not 31 May 2018.**

Please do also note that the Board has taken a decision to impose a late application fee for all applications that will be received from now (after date of this correspondence) until 23 May 2018. The late application penalty is applicable to all categories, except only for boxers. For now, we are issuing only a stern warning to boxers that next time, they should please ensure that they renew their licenses on time (i.e., **31 Marcy 2019** or before). The late penalty fees for specified categories, excluding boxers are as follows:

- a) Boxers: **R 250.00** (No penalty fee imposed for now)
- b) SA/International Champion: **R750.00** (No penalty fee imposed for now)
- c) Promoters:
 - Development: **R2 255.00**
 - National: **R3 355.00**
 - International: **R5 555.00**
- d) Managers: **R605.00**
- e) Trainers: **R605.00**
- f) Seconds: **R275.00**
- g) Ring Officials:
 - Grade A: **R825.00**
 - Grade B: **R495.00**
 - Grade C: **R275.00**

As per usual procedure, you are further reminded that the licensing procedure still remains unchanged i.e.:

- a) Complete a renewal application form for the category of interest. Renewal application forms are available on the BSA website and/or from the BSA Provincial Managers
- b) Attach all required supporting documentation.
- c) Make payment to the BSA account using **Name and Surname** as reference.

- d) Submit the completed form application together with proof of payment to the Provincial Manager of the region which you are applying at.
- e) No renewals will be accepted without a completed application form.
